### **The purpose of data processing and the legal ground:**

Your data is processed:

1) **For the purpose of performing the medical services** recommended by your doctor in order to establish a medical diagnosis / providing medical services / providing a medical treatment. The processing is necessary for the execution of the services you have requested, in accordance with the national legislation in force and with art. 6 par. (1) (b), Art. 9 par. (2) lit. h) of the RGPD<sup>1</sup> as well as for the fulfillment of the legal obligations of archiving, tax reporting, etc., to Inter Health Systems SRL in accordance with art. 6 par. (1) (c) of the RGPD.

You also have the right **to request restriction of processing** (to mark certain data in order to limit further processing), **to oppose the processing** for reasons related to your particular situation.
